Most of the advocacy done in the past year was forwarding articles of interest concerning Native issues via email. Below are examples:

- ✓ 11/20/22 New York Bans Native Mascots New York schools ordered to change Native American team names, mascots or risk losing funding
- ✓ 11/29/22 Native Map of Minnesota This week they're unveiling a map that features more than 100 Ojibwe place names from across the Band's territory, including names uncovered in diaries stored in the Smithsonian dating back to the 1800s.
- ✓ 12/6/22 Quincy Mass. Pledges to the Neposet Nation Encouraging news about a mayor taking real steps to honor and provide for a local tribe. Also pledging to, "work to incorporate the tribe's history and legacy into the curriculum of Quincy Public Schools."
- ✓ 12/14/22 Return of the Buffalo Lucille Contreras set out to reconnect her Lipan Apache community with its heritage. She brought buffalo back to Texas Native American land.

- ✓ 3/20/23 SCOTUS Hears Arguments in Navajo Nation Water Rights Case Unfortunately the Supreme Court ruled against the Navajo Nation, a devastating decision for them and a violation of treaties.

- √ 4/27/23 NCAI Supreme Court Project The National Congress of American Indians had created
  Tribal Sovereignty Protection Initiative (TSPI) in September, 2001. One component of that is the NCAI Supreme
  Court Project, a collaboration between NCAI and the Native American Rights Fund monitors litigation in which
  Native people have a significant stake and coordinates strategy among a network of over 250 tribal leaders,
  attorneys, and law professors.

- $\checkmark$  7/8/23 Onondaga Land Rights Landmark Ruling by OAS: Agency Rejects American Argument That the Land Claims Are Too Old and Fixing Them Would Be Too Disruptive to Non-Indigenous Settlers Living Within the Treaty Footprint.
- $\checkmark$  7/25/23 − NC Land Acknowledgement − I sent a photo of the wonderful land acknowledgement that I saw on the door of the North Carolina Museum of Art; it's a great example to emulate.
- ✓ 7/26/23 Introducing Kevin Witt of Susquehanna Conference At the NEJ Executive Committee meeting last night we heard from Kevin Witt who is the Director of Beloved Community for the Susquehanna Conference. Among his other assignments he has been charged with the task of revitalizing their CONAM. We agreed to support him as long as he is authentic and listens to the voices of the indigenous people. The first thing we told him that he needs to do is find out what happened to their funds.
